



# ORDER OF EXTRADITION

**Decree No. 07-2024**

**From: The Supreme Ministry of Justice, The Republic of Slowjamastan**

**To: The Honorable Authorities of the United States of America**

**Subject: Extradition of Jonathan Gonzalez**

Greetings to our esteemed friends in America,

It is with a mixture of bewilderment and bemusement that The Supreme Ministry of Justice of The Republic of Slowjamastan addresses this communiqué to the venerable authorities of the United States. After careful deliberation and much-needed amusement, we hereby issue an Order of Extradition for one Jonathan Gonzalez, an American citizen, to be transported to the hallowed grounds of Slowjamastan.

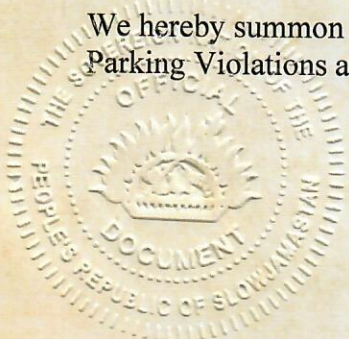
**Reason for Extradition:**

We hereby summon Jonathan Gonzalez to stand trial in the prestigious Court of Unwarranted Parking Violations and Miscellaneous Nonsense in Slowjamastan.







### **Charges:**

1. **High Treason Against the Sultan's Honor**
  - For daring to question the parking prerogatives of His Excellency.
2. **Disturbance of the Royal Peace**
  - For causing undue stress and mild inconvenience to The Sultan.
3. **Unwarranted Citation Issuance**

### **Terms of Extradition:**
